Cost includes:

Itinerary:

Day 1. Warsaw. Meeting Day

Your arrival in Warsaw. In the afternoon we will invite you to a welcome dinner.

Day 2. Warsaw

Guided tour of the capital of Poland. Visit to the Museum of the History of Polish Jews.

Day 3. Warsaw. Wilanów

Visit to the Wilanów Palace - a baroque royal residence, property of Jan III Sobieski, one of the last great kings of Polish-Lithuanian Commonwealth. Cooking classes.

Day 4. Olsztynek. Gdańsk

This day we will leave Warsaw and travel to Gdansk. On the way visit to the Ethnographic Park in Olsztynek with buildings of large and small regional architecture from Warmia, Mazury, Powisle and Little Lithuania.

Day 5. Gdańsk

The guided tour with local guide from Gdańsk. In the afternoon entrance to the European Solidarity Centre in Gdańsk shipyard.

Day 6. Gdańsk and Gdynia

Visit to the Emigration Museum in the port of Gdynia. The exhibition presents the history of departures from Polish lands over the centuries. In the afternoon coming back to Gdańsk where you will meet the amber processing master and see the show of amber processing.

Day 7. Malbork. Toruń

Visiting Malbork Castle – the largest teutonic castle in Poland and one of the largest castles in the world. Travel to Toruń.

Day 8. Toruń

Guided tour in Toruń, a picturesque medieval city, the hometown of Nicolaus Copernicus, famous for its delicious gingerbread.

Day 9. Częstochowa. Kraków

Stop in Częstochowa to visit the Jasna Góra Monastery with the Black Madonna Sanctuary. Country party in Kraków in the evening.

Day 10. Kraków. Auschwitz or Wieliczka half-day trip

For this day, you will have 3 options to choose from: Auschwitz Birkenau Museum, Wieliczka Salt Mine or free time in Kraków.

Day 11. Kraków

City guided tour. You will visit Wawel Castle and Main Market Square with St. Mary’s Church.

Day 12. Kraków. Departure

After last common breakfast in the hotel we will transfer you to the airport.

Supplements:

- SGL room supplement: 3360 Polish zlotys per person
- supplement for the additional day in Kraków for guests who wish to visit both Auschwitz Museum and Wieliczka Salt Mine. The supplement includes the additional night at the hotel, entrance ticket (ticket to one attraction is included in the general tour price) as well as private transportation: to be determined
- supplement for transportation to Warsaw airport on the departure day: to be determined

Weather and climate

Please be prepared for changing weather: a warmer garment should be included and comfortable shoes are a must. The summer is mild here, with temperatures ranging between 50 and 70 degrees Fahrenheit. However remember, the weather can be capricious in May.

Health

When coming to Poland no special vaccinations are required. In case of any illness you can pay to use the services of the local healthcare system. In the tour package cost of the tour there is included medical, insurance (see the Insurance section for details). in case of an accident, sudden illness, injury, poisoning or life - threatening conditions, you are entitled to receive all forms of medical treatment without a referral.

Electricity

230v/50 cycles. Allpurpose transformer and 2prong adapter is required for U.S. appliances.

Tipping

Not obligatory, but appreciated. Cab drivers and waiters accept between 10-15%. In some places there is also a nominal charge for use of cloak rooms and public restrooms.

Currency and credit cards

Polish monetary unit is Zloty divided into 100 groszy. 1 Polish zloty (PLN) = about 0.25 US dollars (USD) (November 2024)
VISA, MasterCard credit cards are accepted in major shops, restaurants, cafes, hotels.

Internet

You will have wifi (wireless Internet connection) in all your hotels.

Tour terms and conditions:

Documents

A valid passport is required. Check the validity of your passport and be sure it is valid for at least three months after your return date.

Insurance included in the tour package cost

- medical insurance: covered costs up to 20000 EUR per person
- accident insurance: covered costs up to 10000 Polish zlotys per person
- third party insurance: covered costs up to 50000 Polish zlotys per person

Higher forces

It might occur partial or complete breach of contract, caused by unforeseeable events such as fire, war, natural disaster, or any other, which may have an impact on the fulfillment of the services. In such unforeseen cases we will reimburse all the funds except for actual expenses incurred till the moment the higher force has occurred.

Complaints

All formal complaints must be submitted in writing (email, regular mail) no later than 30 days after the end of the Tour. The client is requested to report timely anything they were not satisfied with. Delayed complaints decrease our ability to deal with the problem and will thus exclude our responsibility.

We will refund the difference between the contracted services and the replacement services, on the condition that the Client does not receive replacement services of the same or higher value. The Client covers the costs of all replacement and extra services of a higher value if they are delivered at his/her request.
